I authorized the Principal, SVV and through his staff to act in loco parents of my ward not only in school but also in tours, treks, camps etc. and take necessary action on my behalf in any emergency, surgical operation or any other such condition where my permission is needed but cannot be obtained in time.
6. I agree that in the event of my ward being withdrawn during the course of the year whatever the reason may be, the full fees charged by the school for the whole year will be paid by me.
7. The Principal, SVV is fully empowered to remove my ward if in his opinion my ward has failed to maintain the discipline of the school and her further stay in the school is detrimental to the interest of the other students of the school and/or my ward fails to come up to the academic standard of his/her class.
8. If my ward is found accused or guilty of any criminal charge or misconduct or persistent negligence of work or misbehavior the Principal, SVV may remove or rusticate him/her from the school & hostel.
9. I understand and agree that the legal jurisdiction, for any legal dispute pertaining to the school will be the court, at Madhepura.
